

# **DEXTER TOWNSHIP ORDINANCE NUMBER 9**

---

## UNIFORM TRAFFIC CODE

ADOPTED: APRIL 9, 1970

AN ORDINANCE TO ADOPT BY REFERENCE THE UNIFORM TRAFFIC CODE FOR MICHIGAN CITIES, TOWNSHIPS AND VILLAGES; AND TO ADD CERTAIN SECTIONS THERETO.

THE TOWNSHIP OF DEXTER ORDAINS:

### **SECTION I**

1. **CODE ADOPTED:** The Uniform Traffic Code for cities, townships and villages promulgated by the Commissioner of State Police on February 14, 1958 and published in Supplement No. 13, and as amended both on February 14, 1961 and published in Supplement No. 25, and on February 26, 1968 and published in Supplement No. 54, to the 1954 Michigan Administrative code, in accordance with Public Act 62 of 1956, State of Michigan, is hereby adopted by reference as in this ordinance modified.

### **SECTION II**

1. **REFERENCES IN CODE:** References in the Uniform Traffic Code for Michigan Cities, Townships and Villages to "governmental unit" shall mean the Township of Dexter.

### **SECTION III**

1. **ADDITIONS TO UNIFORM CODE:** The following sections are hereby added to the Uniform Traffic Code previously adopted herein by reference:
  - A. **Section 2.5 (i)** When a vehicle is left unattended without permit in any public park past the closing hour of said park.
  - B. **Section 5.100** Vehicles shall not be driven off roadway. The driver of a vehicle shall not drive off the roadway in a public park, except into a designated parking area.
  - C. **Section 8.10 (s)** On or along the roadway in a public park, or off the surfaced area of a designated parking lot.
  - D. **Section 8.10 (t)** Past the posted closing hour in any public park.

### **SECTION IV**

1. **PUBLICATION OF ORDINANCE AND NOTICE:** This Ordinance shall be published in full in the Ann Arbor News, a newspaper of general circulation in the Township of Dexter, qualified under State law to publish legal notices, within ten (10) days after its adoption and the same shall be recorded in the Ordinance Books of the Township and such recording authenticated by the signatures of the Supervisor and the Township Clerk. At the same time, a supplementary notice shall be published in the Ann Arbor News setting forth the purpose of the said Uniform Traffic Code

and the fact that complete copies of the Code are available at the office of the Clerk for inspection by and distribution to the public at all times.

### **SECTION V**

1. **EFFECTIVE DATE:** This Ordinance shall take effect and be in full force thirty (30) days after the publication set forth herein.
