#### THE TOWNSHIP OF DEXTER ORDAINS:

### **SECTION I**

- 1. Section III(1)(B) of the Floodplain Management Ordinance, previously adopted by the Dexter Township Board of Trustees on the 21<sup>st</sup> day of February, 2012, through Dexter Township Ordinance No. 39, is hereby amended by deletion of Subsection III(1)(B) and the substitution of the following provisions in its place and stead:
  - B. The Flood Insurance Rate Maps (FIRMS), panel numbers 26161C0050E, 26161C0065E, 26161C0070E, 26161C0184E, 26161C0185E\*, 26161C0203E, 26161C0205E\*, 26161C0207E, 26161C0209E, and 26161C0210E, and dated April 3, 2012.

## **SECTION II**

 PUBLICATION AND EFFECTIVE DATE: This ordinance shall be published once in a newspaper having general circulation in the Township of Dexter and shall take effect on April 27, 2012.
