1. It is hereby requested that Dexter Township grant approval of an exclusive Permanent Access Easement to serve the following described parcel:
2. In compliance with Section III, Part C of Dexter Township Ordinance #21, as amended, two (2) copies of the following information:

(initial if completed)

- a. Legal description of the lot or parcel to be served.
- b. Legal description of the Permanent Access Easement.
- c. Names and addresses of all persons or parties owning an interest in the title to the property to be served.
- d. Drawing of the lot or parcel with the dimensions and bearings showing the outline of the proposed Permanent Access Easement and placing the location of any improvements.
- e. Driveway permit issued by Washtenaw County Road Commission.
- f. Proof of registration and/or recording of the Permanent Access Easement with the Washtenaw County Register of Deeds.

3. In compliance with Section II, Part C of Dexter Township Ordinance #21, as amended, the Permanent Access Easement shall meet the following standards and specifications:

(initial if compliant)

- a. The Permanent Access Easement shall be exclusive and shall serve only one (1) single-family residence.
- b. The driveway within the Permanent Access Easement shall meet the standards of Section 22.09 of the Dexter Township Zoning Ordinance.
- c. The minimum width of the Permanent Access Easement shall be sixty-six (66) feet.
- d. Some means of turnaround must be provided, either in the easement or property served.

e. The connection between the Permanent Access Easement and a public street shall conform to the standards and specifications of the Washtenaw County Road Commission. Any connection between a Permanent Access Easement and an approved Private Road shall conform to the specifications of Dexter Township Ordinance #21, and the applicant shall secure the approval of the Dexter Township Board of Trustees for said connection.

4. I understand that the address shall be posted for the parcel served in accordance with the requirements of the Dexter Township Zoning Ordinance.
