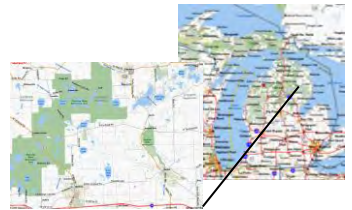

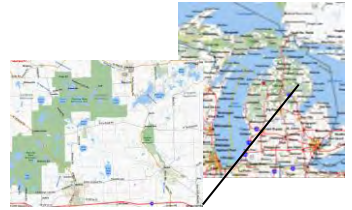

2020 DEXTER TOWNSHIP AGREEMENT
Waterloo Road over the Tributary to Four Mile Lake
Construction

THIS AGREEMENT made and entered into this ____ day of _____, 2020, by and between the Dexter Township Board of Trustees (Dexter Township), Washtenaw County, parties of the first part, and the Washtenaw County Board of County Road Commissioners (WCRC), parties of the second part.

WHEREAS, the parties desire that certain improvements be made to the Waterloo Road culvert crossing the Tributary to Four Mile Lake, located on a local road in Dexter Township (the Project); and

WHEREAS, the WCRC will commit to fund a share of the construction costs associated with the proposed structure replacement; and

WHEREAS, the proper authority is provided to the parties of the agreement under the provisions in Act 51 of Public Acts of 1951, as amended.

IT IS NOW THEREFORE AGREED, the parties of the second part will complete the construction for the replacement of the Waterloo Road culvert crossing the Tributary to Four Mile Lake in accordance with standards of the parties of the second part; and

IT IS FURTHER AGREED that all Project costs associated with the construction will be split equally between Dexter Township and the WCRC; and

IT IS FURTHER AGREED, on May 18, 2020, the WCRC will submit an invoice to Dexter Township for the Dexter Township share based on the estimated construction cost of said improvements. Following a final accounting of the construction cost, the WCRC will submit a final invoice for any actual remaining unpaid costs. Dexter Township agrees to remit payment within 30 days from receipt of each invoice. The final invoice shall provide supporting detail and information, which reasonably identifies the Project costs.

The W.A.V.E. Board met on Friday, April 10 via Zoom.

At the April 10th virtual meeting the WAVE Board discussed the effects of the March 14th suspension of operations, with the exception of providing dialysis transportation. The Board agreed to continue the same service level as agreed on March 14th, as well as to lay off all non-essential employees. Essential hourly employees who will continue are: Lead Dispatcher; Fleet Coordinator/Maintenance/Field Work; Driver/Vehicle Cleaner.

In addition, the WAVE Board agreed to place route contracts on hold for Chelsea Retirement Community, Chelsea Area Senior Center and the new St. Joseph Hospital (Chelsea) shuttle.

WAVE will also be installing protective shields around driver compartments in the busses.

MDOT and AAATA have agreed that pass-through funding is still available for continuation of the limited operations and the protective shields.

The next meeting is scheduled for 8:00 AM on Tuesday, April 29, 2020. That meeting may continue as scheduled as a virtual meeting, or may be cancelled.
