## MEETING OF: Township Board of Trustees 18 August 2020

#### **Staff Comments:**

Township legal counsel recommended an appraiser. I contacted that firm, but they are unable to accommodate our request at this time. They recommended another appraiser, whom I contacted and requested a quote. That appraiser was unable to provide an actual quote, due to the complexity of the project. That appraiser agreed to evaluate my request, but also recommended another appraiser. I contacted the third appraiser and discussed the issue. That appraiser will review the information and get back to me.

Rough information from both appraisers indicate the cost for an initial appraisal anywhere from \$1,500 to \$5,000, with an hourly rate for MTT appearance from \$125/hr to \$200/hr.

We did not budget for any independent appraisal, so the Assessing department budget would require amending once we have a better idea of the actual cost of answering the MTT action.

I have prepared two options for the Board to consider. Both motions are the same, except for approval authority, and both options require consultation with, and approval by, the Township Assessor and Township Attorney. Option 1 allows the Township Supervisor to select the appraiser, Option 2 allows the Township Executive Team to select the appraiser.

#### Motion/Action/Recommendation:

**Option 1 – Motion to** authorize an independent appraisal for the property at 9091 McGregor Rd. at an initial cost not to exceed \$5,000, and to authorize the Township Supervisor to select the appraiser after consultation and approval of the Township Assessor and Township Attorney.

**Option 2 – Motion to** authorize an independent appraisal for the property at 9091 McGregor Rd. at an initial cost not to exceed \$5,000, and to authorize the Township Executive Team to select the appraiser after consultation and approval of the Township Assessor and Township Attorney.

#### **Staff Comments:**

The Executive Team, along with Mr. Rohr, interviewed Mr. Zsenyuk and agreed that he would be an excellent fit in the position of Zoning Officer. He retired from the Ann Arbor Police Department at the rank of Lieutenant. He also worked post-retirement for Northfield Township PD and Adrian Township PD, where he handled local ordinance issues.

Note 1: Clerk Ceo worked with Mr. Zsenyuk at Ann Arbor PD, and Supervisor Rider has known Mr. Zsenyuk professionally for more than 30 years.

Note 2: The Executive Team allowed Mr. Zsenyuk to work on August 7<sup>th</sup> to spend time with Mr. Curtis, and to work with Mr. Rohr at mutually agreeable days/times during the week of August 10<sup>th</sup> to become familiar with the duties of the position, understanding that full employment was still subject to approval by the Township Board.



#### **Types of Zoning Permits Issued-** (All zoning permits are for July.)



Director of Planning & Zoning, Mr. David Rohr gave the PC an overview of this Preliminary Site Plan Approval request.

Mr. Todd Pascoe, senior engineer at Atwell LLC detailed the specifics of this 48 home OSC/site condo project for the PC.

(Note: In reviewing the 'Official Zoning Map' for new draft ZO, the Board made a policy change decision on zoning changes from Ag to RR that limits this development to just 48 homes. This is a 38% reduction in the number of homes allowed i.e. 48 in AG vs 78 with RR = 30 less homes. The Board must balance property rights zoning changes with the public interest).

This OSC plan is compact, with more open space preserved because it places a **home, septic and well** on just .46 acres i.e. on **less than a half-acre**. (i.e. lot size = 80'x250')

This documents that on-site septic & well can be achieved on half-acre lots. This has been accomplished for decades in some of Livingston County most exemplary OSC's. Thus, One-acre is NOT the minimum size lot for septic & well.

However, with on-site septic, some homes will require deep excavation septic systems. However, that's the purview of the Washtenaw County Health Department who will require review and approval all proposed septic fields and wells. Their experts say that deep excavation fields do not create a problem because wells are so much deeper.

#### **Public Hearing:**

Residents expressed safety concerns about the proximity of the pipe line to homes. Mr. Pascoe responded you can legally build right up to the easement & potential home owners will be notified of the pipe line in the Master Deed.

Other issued raised included, traffic congestion, traffic accidents and too many homes & too many subdivisions that may suck up the groundwater needed for neighboring homes. Mr. Pascoe's response was that a groundwater hydrogeo study will be conducted by the health department.

#### PC deliberations:

The planning commission questioned the 8 additional homes allowed for (subjective) 'superior design' and also safety aspects of this OSC.

- PC questioned SWM superior design. Our current ZO does not require that we follow the WCWRC SWM standards (but our MP does). These standards generally favor on-site infiltration to large detention/retention ponds.
  - (The MP requires us to use 'Natural Systems' for SWM to the greatest extent possible to protect our lakes ... not the pipe & pond approach that we are using here with THREE stormwater ponds. And this 'superior design' has homes open space viewshed overlooking these storm ponds).
- PC wanted a plan with no access to North Territorial because of a major safety concern. Commissioner Straub pointed out that the large hill at N. Territorial & Dexter-Town Hall Rd. creates a dangerous safety issue because of the ingress/egress traffic from N. Territorial.
- PC also questioned traffic study volume dates since the study was not done during the heavy traffic school months.
- PC questioned house style design & target market, and felt for *superior design* the lots (80'x250') should be wider (at least 100'wide) with 15' side yard setbacks (not 10') so homes were not so close together.
- PC also had questions on the pipe line as well as the future of farming on this property. Ag won't continue forever & will get invasive species. Thus, a natural prairie meadow is preferred.

As recommended by the DPZ Rohr in his report, the PC choose option three:

"If the Planning Commission determines it needs additional information in order to review either the petition for compliance or feasibility, it should direct the applicant to provide such information and <u>postpone review</u> of the petition until a later date. (For noticing purposes, it is ideal to postpone to a specific date.)"

Thus, the PC moved to postpone preliminary site plan review until September 22, 2020 in anticipation of receiving requested information.

Set Public Hearing for (20-PC-203) LaFontaine Property, 11485 N. Territorial Rd., Special Land Use/Preliminary Site Plan Approval.

The PC moved to set this public hearing for review of completeness for August 25, 2020.

During the month of July there were 142 calls for service. During this time Deputies made 29 traffic stops with 1 citation issued.

Noteworthy events in Dexter Township during last month include:

On July 8<sup>th</sup> Deputies responded to the area of North Territorial Rd. and N. Lake Orchard Dr. for a single motor vehicle crash. The vehicle drove off the road and crashed into the ditch although the driver did not sustain any injuries. The driver was arrested on suspicion of operating while intoxicated.

On July 25<sup>th</sup> Deputies responded to the 12000 block of Oak Hill Dr. for a report of domestic violence. Through the course of the investigation it was learned that the suspect had pushed the victim off of a bed and stepped on the victim causing minor injuries. The suspect was arrested for domestic violence and transported to the Washtenaw County Jail. This case is open and ongoing.

On July 27<sup>th</sup> Deputies responded to the 4000 block of Wylie Rd. for a report of a vehicle theft. The victim stated that he lives with his grandparents at this location and will often leave his black jeep in the driveway unlocked and with the keys inside. According to the victim, he had arrived home the previous night around 10:00 pm. and parked his jeep in the driveway with the keys in it. When he woke up in the morning (7/27) his jeep was missing. This case is currently open and under investigation.

The "no wake" buoy on Portage Lake was found damaged over the July 24<sup>th</sup> weekend. Marine Deputies located the damaged buoy near Klaves Marina and pulled it to shore. It appears the damage was caused by a prop from another boat, which then drug it to the area in front of Klaves Marina. The damage to the buoy was minimal and was repaired by Marine Deputies by purchasing Marine epoxy and sealing the apparent prop damage. The buoy was placed back onto Portage Lake and is operational at this time.
