**A RESOLUTION ASSERTING TOWNSHIP BOARD  
RIGHT TO APPROVE MASTER PLAN**

Resolution adopted at a regular meeting of the Board of Trustees (the “Township Board”) of the Township of Dexter (the “Township”), Washtenaw County, Michigan, held at the Township Hall, 6880 Dexter-Pinckney Road, Dexter, Michigan on July 18, 2023 at 6:00 p.m.

**WHEREAS**, PER The Michigan Planning Enabling Act (“MPEA”), MCL 125.3801 *et. seq.*, sets forth the requirements for adopting or amending a township master plan.

**WHEREAS**, Pursuant to MCL 125.3843, the MPEA authorizes a township board to assert by resolution its right to approve or reject the proposed master plan or plan amendment approved by the township planning commission.

**WHEREAS**, If a township board approves the proposed master plan, MCL 125.3848(3) requires that a statement recording the Township Board’s approval of the master plan, signed by the township clerk, shall be included on the inside of the front or back cover of the master plan, and if the future land use map is a separate document from the text of the master plan, on the future land use map.

**WHEREAS**, If a township board rejects the proposed master plan, MCL 125.3848(4) requires that the township board submit to the planning commission a statement of its objections.

**NOW THEREFORE BE IT RESOLVED**, Resolution adopted at a regular meeting of the Board of Trustees (the “Township Board”) of the Township of Dexter (the “Township”), Washtenaw County, Michigan, held at the Township Hall, 6880 Dexter-Pinckney Road, Dexter, Michigan on July 18, 2023 at 6:00 p.m.
