

**Dexter Township Resolution # 20-580**

**A resolution to enact an ordinance to amend the Boating Control, Big Silver Lake, Washtenaw/Livingston Counties Ordinance to add the Department of Natural Resources language regarding Daylight Saving Time and to change violations to a civil infraction.**

WHEREAS, Dexter Township Ordinance Number 3-A, adopted in June, 1965, prohibits "high speed" boating on Silver Lake between the hours of 6:30 PM and 10:00 AM, and;

WHEREAS, the stated operational hours on Silver Lake did not consider Daylight Saving Time, and;

WHEREAS, on February 18, 2020, the Dexter Township Board approved Resolution 20-563 to request that the Michigan Department of Natural Resources (MDNR) revise its rules to accommodate Daylight Saving Time, and;

WHEREAS, the MDNR Rules have been modified to accommodate Daylight Saving Time, and;

WHEREAS, it is appropriate to amend the Township Ordinance for Silver Lake to reflect the MDNR rule, and;

WHEREAS, it is also appropriate to amend Ordinance Number 3-A to change the penalty from a misdemeanor to a civil infraction:

NOW, THEREFORE, BE IT RESOLVED THAT the Dexter Township Board, by a vote of the majority at a regularly scheduled and duly noticed meeting held this 21<sup>st</sup> day of July, 2020, amends Dexter Township Ordinance Number 3-A to reflect the MDNR rule that accommodates Daylight Saving Time, and to change the penalty for violation of the ordinance from a misdemeanor to a civil infraction with a \$100 fine, and;

BE IT FURTHER RESOLVED THAT the Township Clerk shall cause the Amendment to be published in the Ann Arbor News on August 2, 2020.

**Dexter Township Resolution # 20-581**

**An Ordinance to Regulate the Possession and use of Fireworks to the Extent Permitted by the Michigan Fireworks Safety Act, MCL 28.451 et seq.**

WHEREAS, Michigan Statutes permit local municipalities to regulate and/or prohibit the possession and use of consumer fireworks except on certain states, and;

WHEREAS, absent such local control as defined by local ordinance, law enforcement officers have no authority to prohibit use and possession of consumer fireworks throughout the year in said municipality, and;

WHEREAS, the Dexter Township Board of Trustees deems it in the public interest to prohibit possession and use of consumer fireworks at times other than required by statute:

NOW, THEREFORE, BE IT RESOLVED THAT the Dexter Township Board, by a vote of the majority at a regularly scheduled and duly noticed meeting held this 21<sup>st</sup> day of July, 2020, enacts Ordinance Number 41 to promote the safety and well-being of the residents of Dexter Township, and;

BE IT FURTHER RESOLVED THAT the Township Clerk shall cause the Amendment to be published in the Ann Arbor News on August 2, 2020.
